The experience of the trainings are optimized with a group of between 10 and 20 participants. This allows for greater participation and opportunity to answer individualized questions.

Research

The research portion of this project is designed to test the effectiveness of the trainings and to assist in furthering the program with the hopes of establishing a permanent resource to parents. Anonymous data materials will be collected from each participant following the trainings to ensure participants privacy is protected and training goals are being met.
